	Screenings \$25	 Eligibility: MPHC health plan members. Service Requirements: Breast Cancer Screening: Between ages 50-74: At least one screening during the measurement year. Cervical Cancer Screening: Ages 21-64: Members who were screened for cervical cancer during the measurement year. Aged 21-64 years with cervical cytology performed within last 3 years Aged 30-64 years with cervical high-risk human papillomavirus (hrHPV) test performed within last 5 years Colorectal Cancer Screening: Within measurement year. Service Requirement: A follow-up visit with any practitioner, for patients with a principal diagnosis of a mental health disorder or with a principal diagnosis of intentional self-harm and any diagnosis of a mental health disorder within 7 days after the ED visit (8 total days). Include visits that occur on the date of the ED visit.
Children/ Pediatrics	Annual Physical \$25 US Family Health Plan	Eligibility: Member must be associated with the PCP in our system. Service Requirement: Perform annual physical which includes Well Child Visit (W30) or Child and Adolescent Well-Care Visit (WCV) during the calendar year and submit claim with appropriate coding.
	Immunizations \$25	 Eligibility: MPHC health plan members. Service Requirements: Member receives at least one vaccine from the following series: ★ • Aged under 2 years: 4 DTaP; 3 IPV; 1 MMR; 3 HiB; 3 HepB, 1VZV; 4 PCV; 1HepA; 2-3 RV; and 2 flu vaccines • Aged under 13 years: 1 meningococcal, 1 Tdap and complete HPV series

To qualify for Primary Care Performance Payments, the described service must be rendered and a properly completed claim submitted for payment.
